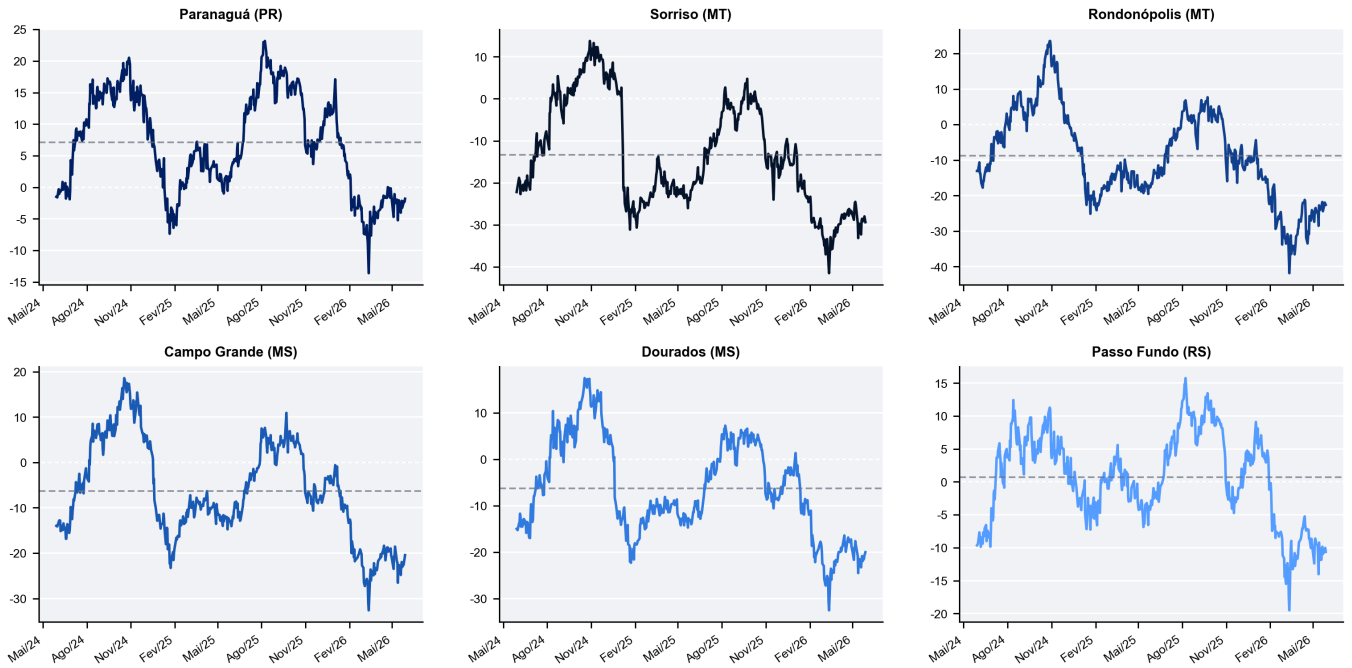

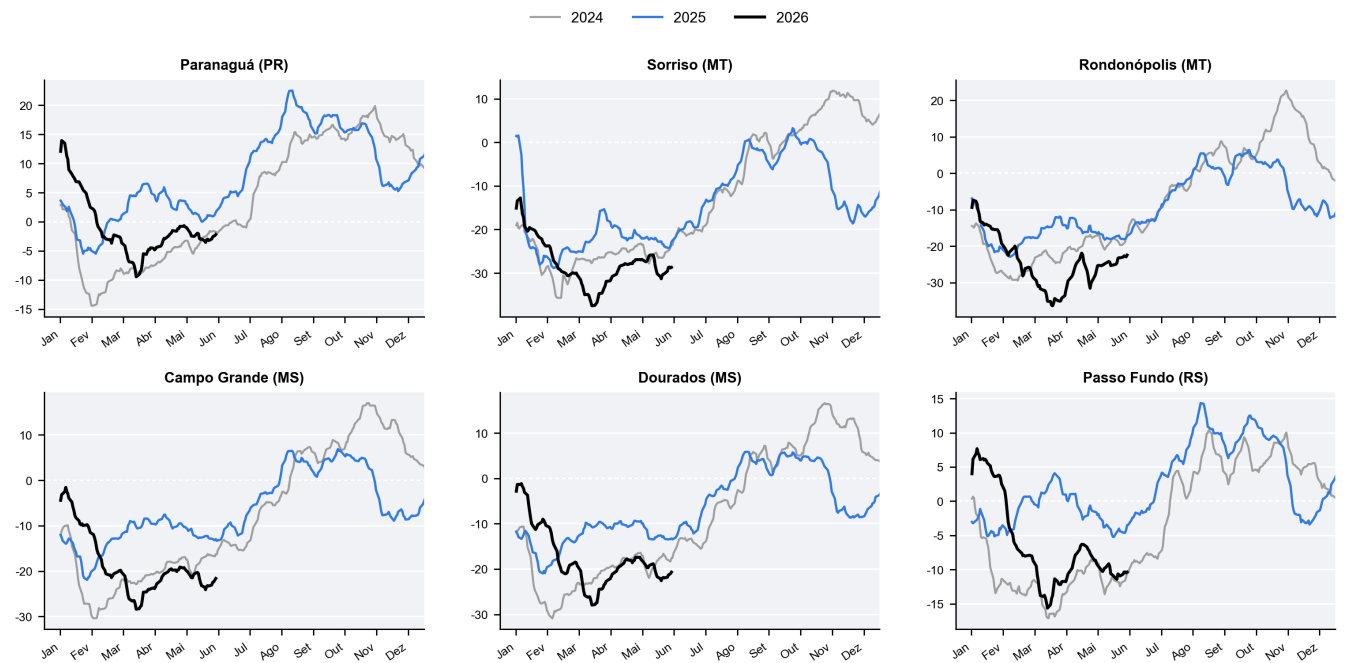

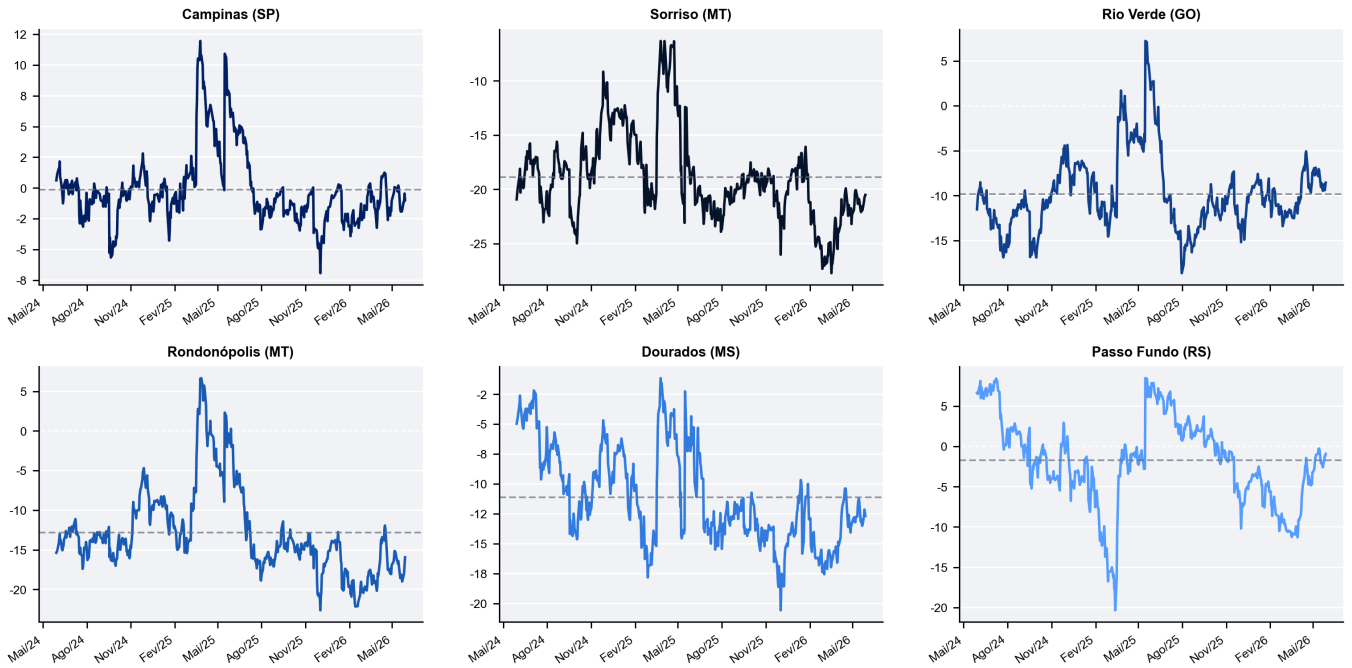
Soja - Sazonalidade do Diferencial de Base

Média móvel de 7 dias do diferencial de base (basis) em relação ao contrato futuro da B3 (R\$/60 kg).



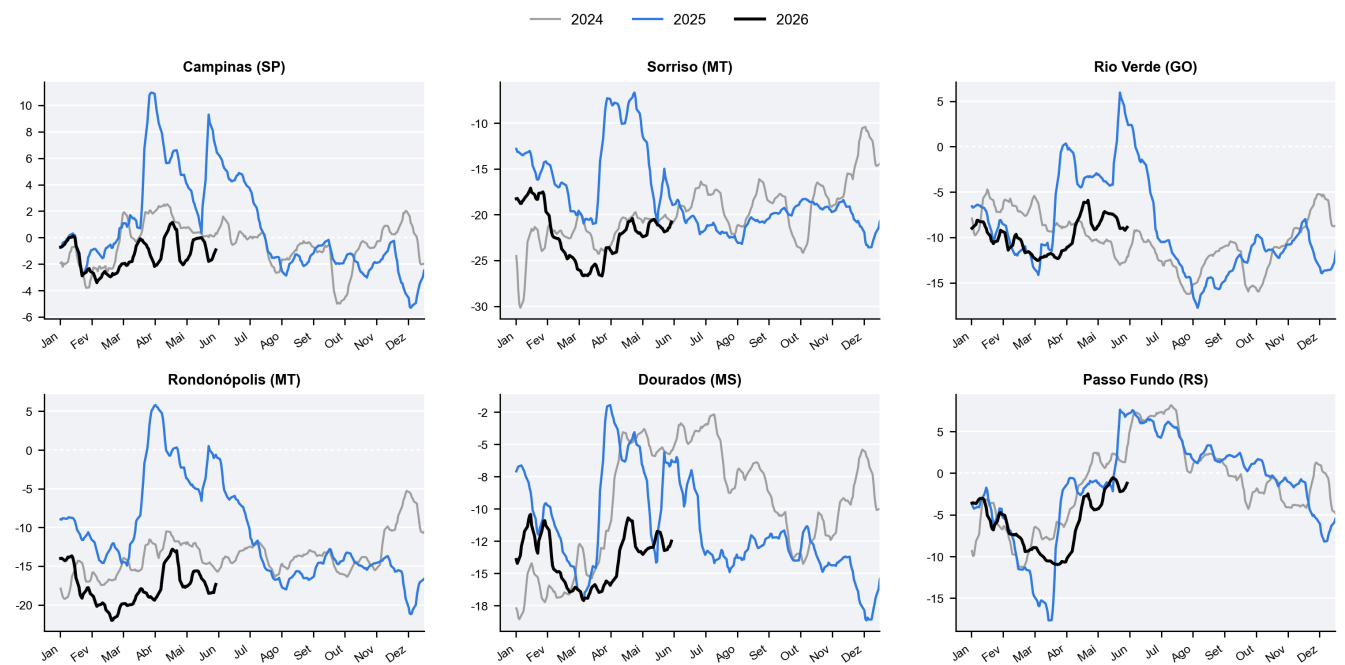
Milho - Diferencial de base

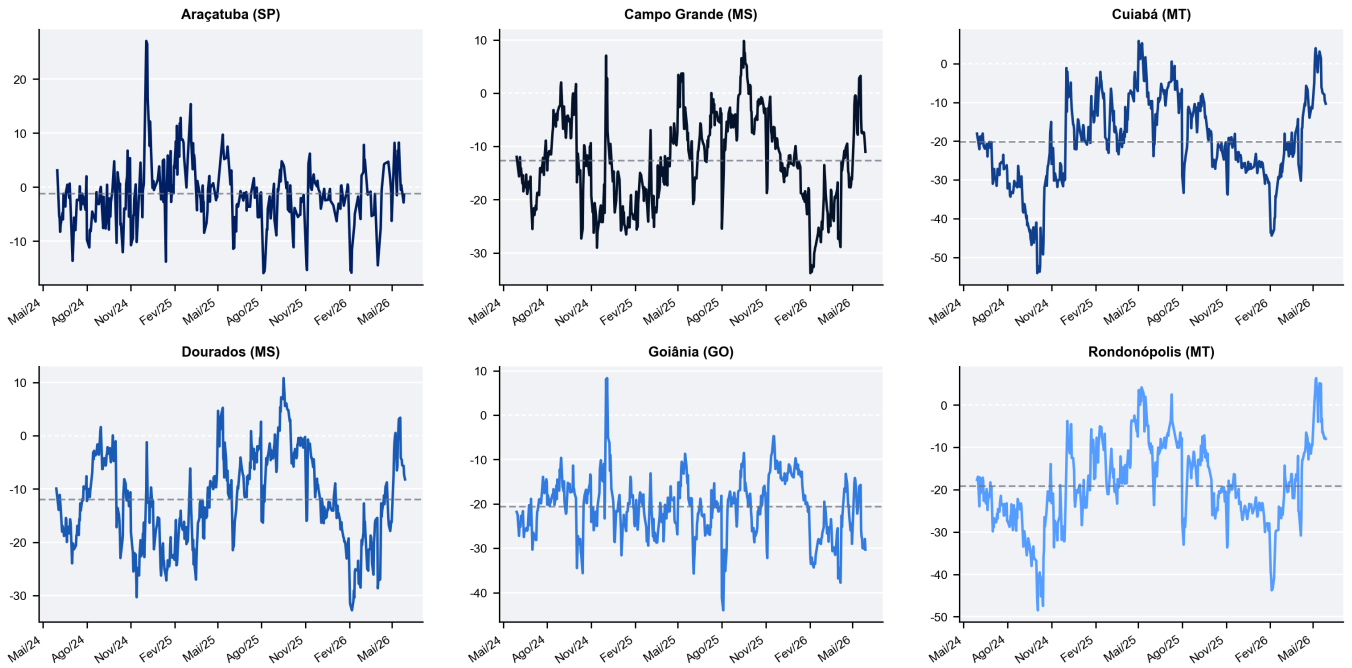
Milho - Sazonalidade do Diferencial de Base

Média móvel de 7 dias do diferencial de base (basis) em relação ao contrato futuro da B3 (R\$/60 kg).



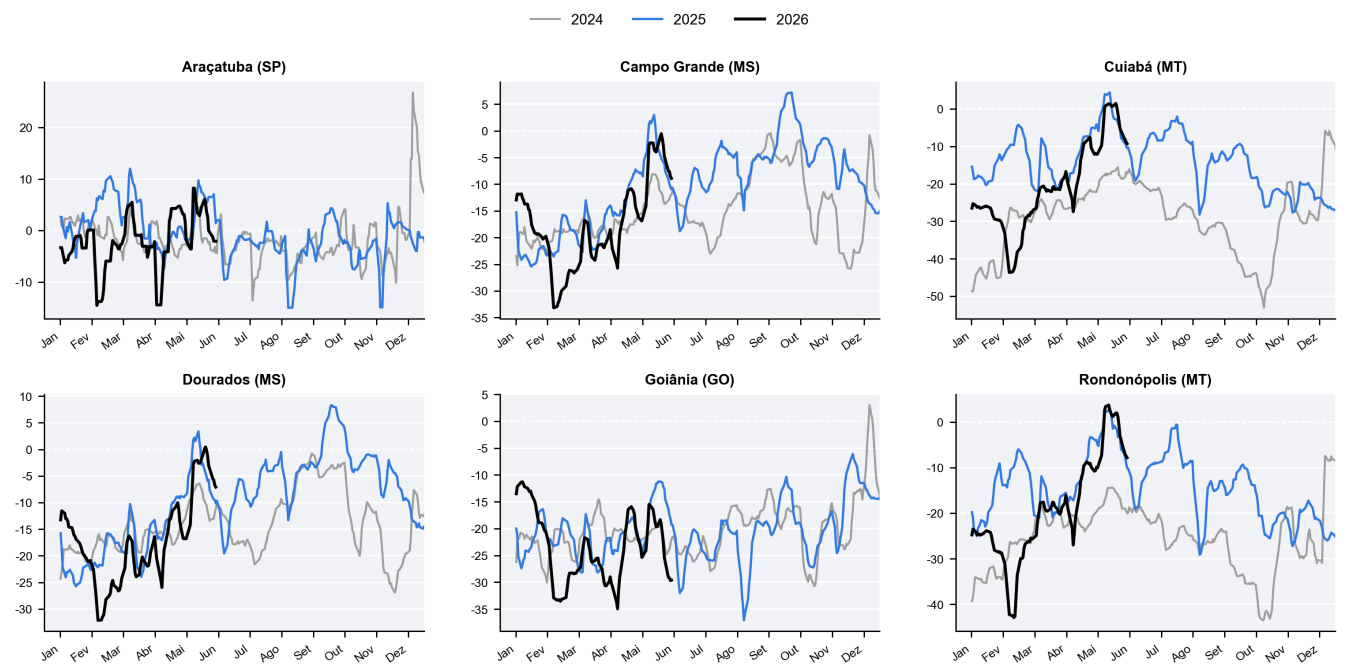
Boi Gordo - Diferencial de base

Diferença dos preços regionais em relação ao contrato futuro da B3 (R\$/@). A linha tracejada em cinza é a média dos últimos 2 anos.



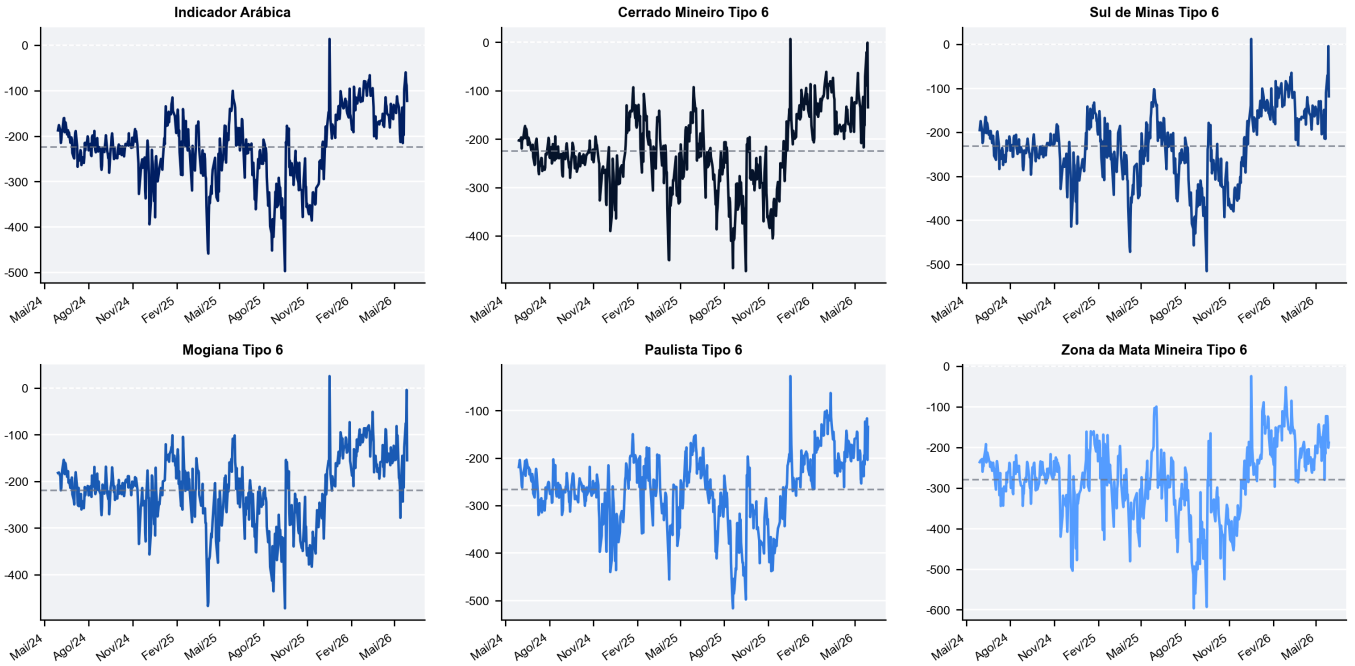
Boi Gordo - Sazonalidade do Diferencial de Base

Média móvel de 7 dias do diferencial de base (basis) em relação ao contrato futuro da B3 (R\$/@).



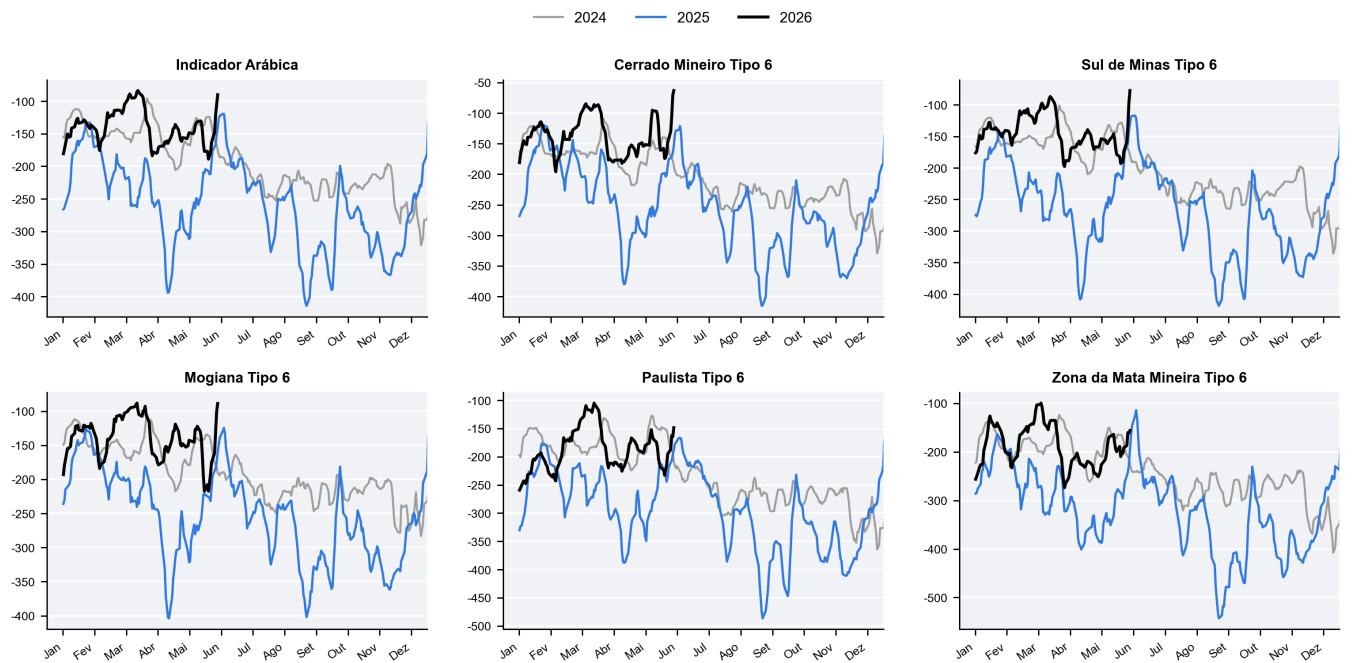
Café - Diferencial de base
